



# Scott County CDA Project Based Housing (2, 3, 4, and 5-Bedroom Units) Waiting List Opening Application and Eligibility Information

#### 1. When is the waiting list open:

• Scott County CDA will accept online applications for its 2, 3, 4, and 5-bedroom Waiting List beginning May 23, 2024 at 8:00 AM and will remain open until further notice.

## 2. How do I apply?

- Applications will be accepted online only at: <u>https://scottcda.org/online-resident-portal/</u>
- Applicants may use any computer, tablet, or smartphone with internet access to apply, including free computers at public libraries.
- Applications will not be available at the Scott County CDA offices, and fax or e-mail requests will not be accepted.
- To request a Reasonable Accommodation due to a disability related to this application, please contact the CDA Office at 952-402-9022.

## 3. Can I apply more than once?

• No, applicants can only be on one application.

## 4. Can I edit my application after I submit it?

## 5. What information do I need to apply?

- A valid email address
- Names, Social Security numbers, and birth dates for all household members
- The household's gross annual income

## 6. What are the eligibility requirements for applying?

- At least one family member must be a U.S. citizen, U.S. national, or non-citizen with eligible immigration status.
- The applicant and all members of the applicant's household must disclose the complete and accurate social security number assigned to each household member.
- You must income qualify per household size. You cannot make more money than the income limits in the chart below:

• Your household size must qualify for the appropriate unit size. **For example**, a 4-bedroom unit must have a minimum of 6 persons, not to exceed 8 persons. To ensure you are applying for the appropriate unit size, see the chart below:

	Minimum number of	Maximum number of
Number of Bedrooms	persons in home	persons in home
2	2	4
3	4	6
4	6	8
5	8	10

\*The following circumstances are exceptions: Live-in aides will be allocated a separate bedroom, Foster adults and foster children will be allocated a separate bedroom.

#### 7. How does the CDA assign bedrooms to household members:

• The CDA will assign the first bedroom to the Head of Household and their spouse or significant other (if applicable). Thereafter, the CDA will assign one bedroom for each two persons regardless of sex, age, or relationship, as shown on the chart below.

1 <sup>st</sup> BEDROOM = Head of Household <u>AND</u> (if applicable) a Spouse or Significant Other
<b>2<sup>nd</sup> BEDROOM</b> = Next 2 persons share a room regardless of sex, age, or relationship.
<b>3<sup>RD</sup> BEDROOM</b> = Next 2 persons share a room regardless of sex, age, or relationship.
<b>4<sup>TH</sup> BEDROOM</b> = Next 2 persons share a room regardless of sex, age, or relationship.
5 <sup>TH</sup> BEDROOM = Next 2 persons share a room regardless of sex, age, or relationship.
