TO ALL BIDDING CONTRACTORS:

All contractors are to note the following clarifications/modifications to the specifications and drawings for the Reroofing of River City Centre.

1. On December 22, 2025, a pre-bid meeting was conducted. Those attending the mandatory pre-bid are on the attached sign in sheet. (See attached Sheet below)
2. Bids are due January 9, 2026 at 10:00 am. Bids are to be delivered to Julie Siegert Scott County CDA, 100 5th Avenue East, Shakopee, MN 55379 where they will be opened and read aloud publicly. A 5% bid bond is to accompany the bid.
3. Construction will take place in the spring of 2026.
4. Prevailing wages do not apply to this project.
5. Performance and Payment bonds are required as part of the contract.
6. Contractors are to note insurance requirements for this project.
7. Safety will be the responsibility of the contractor. Staging area will need to be fenced off. With pedestrian traffic at the front of the building, contractor will need safety measures to protect the pedestrians from falling debris.
8. All permits are the responsibility of the contractor.
9. The project is tax exempt on materials; the owner will provide an ST-3 form for contractors to purchase materials for them. Separate contracts will be written for labor and materials.

10. Site staging and contractor's employee parking will take place in the parking lot on the north side of the building.
11. Any mechanical or electrical modifications necessary to complete the project is the responsibility of the contractor.

Contractors are to acknowledge the receipt of this Addendum on their Bid Form.
